

## What can I deposit?

Research that can be deposited includes:

- Pre-prints (not refereed)
- Post-prints (refereed)
- Working papers
- Published articles
- Books (bibliographic information only)
- Book chapters
- Online journal articles
- ... and other forms of research output

## How do I deposit items?

There are two main ways to deposit your research:

- **Through the website.** There is a deposit form on <http://eprints.bbk.ac.uk>, in the User Area. You will need to register first: click on Register and fill in the online form. A deposit guide is available to help you: <http://eprints.bbk.ac.uk/depguide.pdf>
- **By e-mail.** Send details of the publications you would like to deposit to [lib-eprints@bbk.ac.uk](mailto:lib-eprints@bbk.ac.uk). Repository staff will then check the copyright agreements for you, and deposit the items if it is allowable to do so.

Alternatively, please contact the repository staff (see the contact details in the next column).

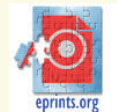

## What is Birkbeck ePrints?



Birkbeck ePrints is an online archival database hosting the full text of published research done at Birkbeck College. Material

stored in the archive is freely available to anyone over the Internet.

By making your research papers available in Birkbeck ePrints you are making it more widely accessible, leading to greater visibility and impact.

Services like Birkbeck ePrints are being developed by academic institutions worldwide.

- It is a mechanism for making research more widely available worldwide.
- It is not a substitute for peer-reviewed journals—the ePrints Service has been developed to host material that has already been published.
- Its intention is to open up the scholarly research literature in the spirit of Open Access.

## How can ePrints help me?

**You write and publish for research impact, not for profit.** You deserve the widest possible dissemination of your work.

Yet current publishing practice too often blunts your research impact—journal publishers make it hard for non-subscribers to see your work.

**The solution is for Birkbeck ePrints to provide an open access copy of the same work you publish in journals or conference proceedings.** This will maximise the impact of everything you publish.

**Greater research impact translates into increased citation rates,** which advance your career and help attract further research funding.

## What are the benefits for me?

**Your academic research is made available to the world scholarly community on a scale impossible in paper.** Papers in Birkbeck ePrints are indexed by cross-repository search facilities, and are also found by search engines such as Google and Yahoo.

**Your research is stored in a central searchable space** rather than being distributed across many publishers' websites. A link from your personal website to the ePrints Service makes the full text of your papers readily available, rather than just the citation as is often the case at present.

**Your research is stored by Birkbeck with a commitment to preserving it.** Your papers on publishers' websites are only available to subscribers, and will only be there as long as the publisher chooses to make them available. The ePrints Service will preserve them.

**You will have access to similar repositories worldwide.** Through OAIster indexing (<http://oaister.umdl.umich.edu>), you will be able to search hundreds of repositories simultaneously—you can easily restrict your internet searches to academic output.

**Easy access to your papers for students.**

Students can have difficulty accessing publishers' websites remotely because of licensing restrictions—remove the difficulties with Birkbeck ePrints.

**You can avoid the delays of print publishing.** Birkbeck ePrints can get your paper online today. Subject to copyright and other agreements with the publisher, either a pre-print (the draft you submit to a journal) or a post-print (the finalised text after refereeing) can be deposited.

**You retain all your intellectual property rights over your own work.** Birkbeck ePrints positively encourages all academics and research workers to retain the copyright on their work. You give Birkbeck ePrints permission to keep your work in a current format and to freely distribute electronic copies of it—nothing else.

## The benefits to Birkbeck, to research, and to society

**The Birkbeck ePrints Service:**

- Helps free research output from access barriers and subscriptions
- Speeds up the sharing of research results
- Provides a secure storehouse for research in perpetuity
- Demonstrates the breadth of research carried out at Birkbeck
- Stores all Birkbeck research output in a single easy-to-access place

## OK, but I'm concerned about ...

**Plagiarism. If I deposit my paper in Birkbeck ePrints (or any Open Access website), what's to stop someone plagiarising my research?**

Open Access does not make plagiarism any easier or more likely than print publication. In fact, Open Access makes the comparison of electronic sources easier, so the *detection* of plagiarism is more likely, so helping to protect your intellectual property rights.

**Copyright. When a paper is accepted for publication, I sign over the copyright. Can I still deposit the paper in Birkbeck ePrints?**

It depends on the publisher. Birkbeck ePrints staff can advise you, and will check the copyright status of any paper you submit to the repository. Of course, you could retain the copyright on any future papers, and sign a non-exclusive licence for the publisher instead. **Prior publication. If I deposit a pre-print of a research paper in Birkbeck ePrints, will a journal say that it has already been published, and refuse to accept it?**

It depends on the journal, and on precisely when the deposit is made. Check with the journal first, or ask Birkbeck ePrints staff to check for you.
